# GENERAL TERMS AND CONDITIONS TO BE NOTED CAREFULLY BY THE TENDERERS

1. Scope of supply: -

The bidder shall have to supply and installation of the Various Types of Lab Equipment as per detailed specifications given in the section-III.

2. Required qualification of the bidder: -

The bidder must have: -

- (i). Registration for GST
- (ii). Valid & active PAN issued by I.T. Department.
- (iii) I.T. return for the last 02 assessment years
- 3. Cost of tender: NIL
- 4. The tender/quotations should be sent through **e-mail only in pdf format** to <a href="mailto:principal@ssipmt.com">principal@ssipmt.com</a>on or before the scheduled last date and time only. Bids received through courier service/by hand / any other means shall not be considered.
- 5. The acceptance of the tender and award of the purchase order will be the sole right of the Principal, SSIPMT Raipur who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reasons and no explanation can be demanded for the cause of rejection of the tender by any tenderer.
- 6. The tenderers should send their offers along with the specifications, necessary drawing/images (if required) which will form the basis of their offer and is an integral part thereof.
- 7. No person or firm is permitted to submit more than one tender under different names.
- 8. The tenderer shall not sublet the contract or assign to any other party or parties, the whole or any portion of the contract.
- 9. Demonstration of equipment through video conferencing mode or physical mode, machine or article available with the firm shall be arranged by the tenderer whenever requested by Principal, SSIPMT, Raipur.
- 10. Manufacturers will be given preference. Copy of license is to be attached with tender for each item filled in, wholesalers/distributors dealing with the item will have to attach copy of authorization certificate of the manufacturer.
- 11. Rates should be quoted for the supply and installation of Various Types of Laboratory Equipment as per the specifications given in the section-III of this tender document.
- 12. In case of any doubt as to the meaning of any of the terms & conditions or the specifications the tendering firm may set forth the particulars there of and mail them to <a href="mailto:principal@ssipmt.com">principal@ssipmt.com</a> well in advance so that such doubts may be removed before submitting the tender any delay whatsoever will not be the responsibility of SSIPMT, Raipur.
- 13. Prices offered by the tenderers should be firm and free from all escalations and shall be valid at least for a period of 120 days from the date of approval of rates.
- 14. The tenderer should quote rate on FOR Destination as mentioned on Work Order basis (Including all expenses- Freight/ Loading/Unloading at site etc.).
- 15. The tender should clearly specify that rates quoted are inclusive of GST as per government norms.
- 16. Depending upon the type of material, the supplier shall have to carry out proper packing/crating to avoid damage during transit. Payment will not be made for damaged goods.

- 17. Warf rage/Demurrage etc. on account of incorrect or delayed dispatch of material/documents shall be the responsibility of supplier and shall be recovered from the bills.
- 18. Insurance of materials being supplied, during transportation is to be arranged by the tenderer at his/her own cost.
- 19. All the materials supplies are subject to inspection at our stores before acceptance. If goods are rejected due to defective or wrong supply, the report of our authorized official in this respect shall be FINAL and no correspondence on the subject would be entertained. The rejected goods should be removed from our premises by the tenderer within 15 days after receipt of our inspection report, failing which the same shall be returned to the supplier at his risk and expenses or disposed off and loss incurred will be completely borne by the tenderer.
- 20. The successful bidder will have to sign an agreement.
- 21. Tenderers may submit their bids for selected items/all items as mentioned in section-III of this tender.
- 22. Local make, poor quality machines OR Local make poor quality machines with different labels put on them will be highly discouraged even though they may be quoted for a lesser price than other bidders.
- 23. All the Supplied items shall be preferably Guaranteed or warranted for a period of minimum 01 year.
- 24. The tenderer must attach proof of at least 02 parties where he has previously supplied the items which he/she is quoting through this tender.
- 25. 10% mobility advance may be paid after finalization of tenderer and after the successful delivery, installation and trial run/testing of equipment/machines supplied, 80% of the cost will be paid within 07 working days and remaining 10% will be paid only after proper demonstration and training imparted by qualified person to the personnel as assigned by SSIPMT, Raipur.
- 26. The training of staff will have to be conducted at our premise at SSIPMT, Raipur Chhattisgarh within a period of 07 days of installation and trial run or the date of release of 80% of payment, whichever is earlier.
- 27. For the trainers coming for demonstration / training food and stay can be provided to them on request and will be charged by SSIPMT, Raipur @ INR 500=00 per person per day.
- 28. **DECLARATION:** The tender submission by the tenderer itself implies that he/she has read all the instructions, terms and conditions laid down in the tender and has completely made himself / herself aware of scope, quality & technical specifications of the machine / equipment to be supplied and, have fully satisfied himself / herself with all related bindings that were expected from him / her through conscious participation.
